Inland Waters Shipping (Amendment) Regulations, 2024 (No. 26)

IT is hereby notified that the Minister of Transport and Infrastructural Development, in terms of section 57 of the Inland Waters Shipping Act [*Chapter 13:06*], has made the following regulations: —

1. These regulations may be cited as the Inland Waters Shipping (Amendment) Regulations, 2024 (No. 26).
