## COLLECTIVE BARGAINING AGREEMENT: FOOD AND ALLIED INDUSTRIES (MILLING SUB-SECTOR)

Made and entered into in accordance with the Labour Act [Chapter 28:01], as amended from time to time between the Grain Millers Association of Zimbabwe (hereinafter referred to as the "employers"), of the one part, and the Milling Industry Workers Union (hereinafter referred to as the "employees"), of the other part, being parties to the National Employment Council: Food and Allied Industries (Milling Industry Sub-sector).

The Collective Bargaining Agreement for the Food and Allied Industries (Milling Sub-sector), published in Statutory Instrument 41 of 1998, is amended by the parties as follows:

The Grain Millers Association of Zimbabwe and the Milling Industry Workers Union met on 8th July, 2020, and agreed on the following:

- (a) the minimum wage for grade A1 to C2 shall be increased by 70% for the period 1st April, 2020, to 30th June, 2020;
- (b) the actual wage of every employee in grade A1 to C2 shall be increased by 70% for the period 1st April, 2020, to 30th June, 2020;
- (c) the housing allowance shall be increased from \$470,00, to \$799,00, per month, for the period 1st April, 2020, to 30th June, 2020.

Collective Bargaining Agreement: Food and Allied Industries (Milling Sub-sector)

(d) the transport allowance shall be increased from \$500,00, to \$850,00, per month, for the period 1st April, 2020, to 30th June, 2020.
