

Being the last publication of the year, it provides us

with that rare opportunity

by- taking stock of the events and activities which shaped the past twelve months. It presents to us a window to share, amongst ourselves, our successes

and challenges during the course of 2021.

We had a slow start to the year owing to the negative effects of COVID-19 on our personal lives and core operations. Lockdowns were effected between January and June; and this had an obvious impact on our courts in particular and the administration of justice in general. The pandemic continued to rob us of our loved ones including colleagues in the organisation. May their souls rest in eternal peace.

The one-stop Court, the first of its kind, houses the High Court, the Magistrates' Court and the Sheriff of the High Court under one roof; and is the pride of collective effort and hard work.

We continued to pursue the trajectory we have taken as the JSC to transform the Judiciary through the introduction of the Integrated Electronic Case Management System in our courts as we look forward to celebrating the conversion of the Constitutional Court, Supreme Court and the Commercial Court into digital courts before the turn of the first half of 2022.

Charged with the sole mandate to train and develop skills of all members of the Judicial Service including Judges and Magistrates, a new baby on the block, christened the Judicial Training Institute of Zimbabwe (JTIZ), was born in 2021- we can only expect excellency in the manner we execute our tasks as we move ahead.

The icing on 2021 was the successful hosting of the Southern African Chief Justices Conference and Annual General Meeting in September 2021, followed by the Leadership Team Building Indaba in November 2021 in Victoria Falls. The indaba, which will now grace our calendars annually, was a historic and memorable event which allowed frank and no-holds barred discussions among all levels of leadership in the JSC.

By the time we publish the first issue of the Miranda in 2022, we would have hosted the traditional ceremony to mark the commencement of the 2022 legal year. We wait with anticipation for the unveiling by the Chief Justice of the theme which will guide us in 2022 as we deliver world class justice to the people of Zimbabwe.

As we move into the festive and merry-making season, it is a time to unwind; to be with our families; and to reflect on the year ending and the year beckoning. I humbly urge all of you to be responsible and to keep safe. We owe it to ourselves and to our families.

# **Chief Justice** tours Hwange and Lupane \_

he Chief Justice Luke Malaba toured **Hwange** the Magistrate's Court and the Lupane Magistrate's Court construction site on the 6th of December 2021 to appreciate the progress subsequent to major renovations and ongoing construction.

An infestation of termites threatened the structure at the Hwange Courthouse coupled with vandalism of the roof by baboons. Staff members also found it uncomfortable to perform their duties under the sweltering Matabeleland temperatures. Since the renovations, Hwange Magistrate Court which is the Matabeleland North Provincial Centre now boasts of world class standards. Provincial Magistrate Mr Zhou expressed gratitude to the Chief Justice and the Secretary for their



timely intervention in sprucing up the courthouse and creating a conducive working environment.

The Chief Justice was taken on a tour of the station and had an appreciation of all the upgrades including one of the courthouses that has glass screens in line with COVID-19 protocols. He then addressed staff members and applauded them for being focused but was quick to remind them about the importance of the public offices they bear.

On arrival in Lupane, Hon. Malaba toured the courthouse but was heavily disappointed by the slow progress at that particular project. The Chief Justice said the JSC is deliberate about completing projects at stipulated times and delays are unacceptable. He then gave an ultimatum to the project team and will be visiting the construction site again during the third week of January 2022 to monitor the progress.

The Chief Justice 's delegation comprised the Secretary Walter. T. Chikwana, Acting Deputy Secretary Mr Elias Muzenda, Head of Administration George Madzikura, Head of Corporate Services C. R Makoni-Thodhlana, Projects Officer Wessley Maenzanise and the Matebeleland North Provincial Leadership from JSC.



Judicial Service Commission (JSC) Secretary Mr Walter Chikwana has recently assumed Charimanship at the Southern African Judicial Administrators Association (SAJAA), a forum that was established to create a common platform for the promotion of rule of law, constitutionalism and good governance among Southern African Development Community (SADC) member states. The Miranda correspondent, Tarisai Mafura had the opportunity to interview Mr Chikwana following his appointment as the Chairperson of SAJAA in October 2021 and below are excerpts of the interview:

**Q** You recently assumed Chairmanship of the Southern African Judicial Administrators Association. How do you feel and what is your vision?

The Association is a forum for Judicial

Administrators and we are humbled as a country to have the opportunity to lead such an important Association which brings together Judicial Administrators in the Southern African Development Community (SADC) region and our desire really is to continue on the trajectory that has been taken by our previous chairperson which is to ensure that there is uniformity in the support that we give to the Judiciary and also to focus on training of the non-judicial members like Registrars, Researchers and so forth.

Q Can you unpack SAJAA for us? What is its mission, goals, values and who are the member states and what binds them together?

A SAJAA is Southern African Judicial Association of Administrators and as I already indicated, it is a forum that brings together the Judicial Administrators



in the SADC region that is about 16 countries in the SADC region. SAJAA operates under the auspices of the Southern African Chief Justices forum. This is a forum of Chief Justices that is under the SADC region in which the Chief Justices meet annually to deliberate on issues pertaining to administration of justice and to promote the rule of law in the region and within the respective jurisdiction of the SADC countries. The Association was formed to support the Chief Justices Forum but more fundamentally to also ensure that we improve in quality of service that we give to members of the public who are approaching our courts. And at the same time, we also provide an efficient and effective administrative support to the judiciaries in our respective jurisdictions.

Q What is your key role as the Chairperson and how important is SAJAA to member states?

A SAJAA has an executive committee which

is consisted of the Chairperson, the Deputy Chairperson, Treasury General, the Secretary General and the Committee Member. The Chairperson in the interim now is Zimbabwe and there is no Deputy Chairperson because Zimbabwe assumed Chairperson after the present Chairperson had retired on medical ground. The Treasury General is Zambia, the Secretary General is Malawi, and the Committee Member is Mozambique. So the decisions that are made in as far as the manner in which SAJAA is supposed to operate are made by the executive committee. In fact, policy decisions are made at the Annual General Meeting when all the member countries meet annually. The executive committee is now mandated to implement those decisions. So as the Chairperson, really you are there to lead the executive committee in the implementation of resolutions which were made at the Annual General Meeting.

Q Your office as Secretary of the Judicial Service Commission is a busy one, how will you juggle SAJAA and your other responsibilities?

Indeed, the office of the secretary of the Judicial Service Commission is quite busy and the work at SAJAA is also quite demanding but fortunately we operate as a committee. It is not a position in which one would work in isolation. We have an executive committee where decisions are made collectively. So really, with the support of the fellow executive committee members, I do not see any difficulty at all in leading the forum.

Q How long is your tenure and what strategic outcomes should we look forward to?

A I am only holding this office on an interim basis up to the time we hold our Annual General Meeting which will be held around October 2022 in Mozambique. That is when we are going to have elections. And when one is elected, you hold office for a period of two years. This is an interim arrangement because the substantive chairperson who was the Executive Director of the Judicial of Namibia had to retire and after her retirement, as the Deputy Chairperson, I was called upon to lead the Association up to the time we hold our Annual General Meeting.

### Death robs JSC

eath has robbed the Judicial Service Commission (JSC) an employee, Mr Mwanyara Ngorima, who was a VIP driver to Honourable Justice Bhunu JA. Mr Ngorima who was also a renowned footballer, died on 14 November 2021 after succumbing to a cardiac arrest. According to his family, Ngorima collapsed whilst at a friend's place of residence in Glen Norah and was rushed to Chitubu Clinic where he was pronounced dead upon arrival.

Speaking the funeral at gathering in Mutare, the Hon Bhunu JA expressed his earnest commiseration to the Ngorima family on the demise of their loved one. He described the late driver as an honest, capable and reliable person who handled his job with

utmost care and responsibility. Hon Bhunu also added that the late Ngorima was not just a driver but he was also like a brother to him. The Bhunu family treated him with great care and kindness as he had become like part of their family. Justice Bhunu urged the deceased's childrenTawanda and Tanyaradzwa to strive so as to achieve their goals and encouraged them to look after their mother well. He stated that the loss of a parent is grief filled and traumatic but it does not mean the end of the world.

Superior Courts Principal Human Resources Officer Ms Shelly Shonhiwa who also spoke at the funeral said it is disheartening to consistently lose members of the staff, adding that Mr Ngorima's sudden death dealt a huge blow to the JSC family.

Mr Ngorima's colleagues told The Miranda that he reported for duty on Friday the 12th of November 2021 without showing signs of illness, only to receive sad news of his death on Sunday. They described the situation as "unsettling" though death is said to be inevitable.

Scores of mourners thronged Dangamvura cemetery in Mutare to pay their last respect to Mr Ngorima. He survived by his wife and two children.

## Did you know?

### **SARS-CoV-2 Omicron variant**

The SARS-CoV-2 Omicron variant is a variant of SARS-CoV-2, the virus that causes COVID-19. The variant was first reported to the World Health Organization (WHO) from South Africa on 24 November 2021. On 26 November 2021, the WHO designated it as a variant of concern and named it after omicron, the fifteenth letter in the Greek alphabet.



The variant has an unusually large number of mutations, several of which are novel and several of which affect the spike protein used for most vaccine targeting at the time of its discovery. This level of variation has led to concerns regarding transmissibility, immune system evasion, and vaccine resistance. As a result, the variant was quickly designated as being "of concern", and travel restrictions were introduced by several countries to limit or slow its international spread.


































































### MISCONDUCT Watch

### CASE 1

The member, who was an Accountant, was charged for contravening paragraph 3 of the Third Schedule of the Judicial Service Regulations, 2015. He failed to efficiently and competently manage the books of accounts during the period extending from 2017 to 2021. During a station visit, it was discovered that the books of accounts at the station were in total shambles. There were grave errors unearthed including errors of accounting, violations of accounting principles in areas of TD accounts, Revenue Accounts, Witness Expenses, Time to pay Records, Warrants of Arrests register, Security items and Court fees that were detected at the station. At one time the member was supposed to bank \$ZWL10 000 but unprocedurally split the banking into two deposits of \$5 000 each. On another day he accumulated a surplus cash of \$2 000 but had no clue where the surplus came from. It was also noted that he processed registrations for deceased estates and peace orders but did not receipt any money resulting financial loss to the Commission. Last but not least, it was also noted that there were recurring delays in banking in contravention of the Treasury Instructions.

The member resigned pending the disciplinary process.

### CASE 2

The member who was a court interpreter was suspended from duty on allegations of theft. She allegedly unlawfully took a CABS bank card belonging to a colleague and withdrew cash amounting to ZWL\$137 642.58 without authority from the owner of the card. She withdrew the cash during the period extending from 3 December 2020 to 3 August 2021. The member was convicted for theft and sentenced to a term of imprisonment which was suspended on conditions of both good future conduct and restitution. The member was discharged from service upon conviction.

### CASE 3

The member who was a watchperson was facing a criminal charge for contravening Section 182 (2)(e) of the Criminal Law Codification and Reform Act for contempt of court. The member allegedly disobeyed a court order that interdicted him from farming on a certain piece of land and proceeded to farm on it. He was arrested for contempt of court.

The member was discharged from the Judicial Service Commission upon conviction.

### CASE 4

The member was charged for contravening paragraph 3 of the Third Schedule of the Judicial Service Regulations, 2015. She flouted the standard operating procedures when she signed procurement minutes for the filing of certain court stations as a member in circumstances where no meeting had actually taken place. The member also signed minutes for fix and supply procurements for court stations as a member despite the fact that no meeting, in which she had participated in, had taken place. This was in violation of settled procurement practices and standard operating procedures governing procurement processes which require that minutes should be generated from a meeting properly held for that purpose. Her conduct therefore resulted in an unfair and unjust comparative bidding process. The member was reprimanded and given a First Formal Warning.

### CASE 5

The member is a senior member of staff with a responsibility for supervising operations at the station where she is in charge. She was presented with procurement documents for recommendations and passed them for payment without exercising due diligence. She recommended the procurement of furniture without making careful considerations of all the relevant documents for procurement. The



member made assumptions about the correctness of the documents and negligently signed and passed the documents for payments without satisfying herself that the documents were in order. This conduct resulted in the comparative bidding process being unfair and unjust as she did not exercise her duties fully in the supervision and checking the correctness of documents she was authorising.

The member was reprimanded and given a First Formal Warning.

### CASE 6

The member who was an Executive Assistant was suspended from duty and subsequently charged with misconduct for contravening paragraph 4 of the Third Schedule. The charge was on the basis that she was transferred to another station but did not proceed to the new station as instructed. Instead, she requested for time to solve her family issues and was granted time off from the 13th to the 17th of September 2021 and instructed to report to her new station after the time off. However, the member only showed up for work at her previous station on the 4th of October 2021 despite several efforts to contact

Upon being asked to give an account on where she had been, the member gave reasons as to why she cannot relocate to the new court instead.

The member was charged for disobeying standing orders and consented to a determination without a disciplinary hearing. She was found guilty and discharged from service.
